title iii of public law 106-200 (114 stat. 251), entitled the united states-south american free trade agreement implementation act (us-safta), amends section 224 of the trade act of 1974 (19 u.s.c. 2411) to provide for the extension of duty-free treatment to certain articles imported from the united states under the us-safta, or any successor agreement, if the article is duty-free for exports to the united states under the us-safta or any successor agreement, or a comparable agreement. the scope of the agreement that is applicable for purposes of this subpart is the us-safta. title iv of public law 106-200 (114 stat. 251), entitled the united states-thailand-korea free trade agreement (us-tkfta), amends section 224 of the trade act of 1974 (19 u.s.c. 2411) to provide for the extension of duty-free treatment to certain articles imported from the united states under the us-tkfta, or any successor agreement, if the article is duty-free for exports to the united states under the us-tkfta or any successor agreement, or a comparable agreement. the scope of the agreement that is applicable for purposes of this subpart is the us-tkfta. in general, an importer of articles subject to the provision of duty preferences, or in certain cases of chargeable entries, under the agreement or the act shall, in order to obtain the corresponding duty preference or duty-free entry, file a complete and accurate claim and, in the case of a claim for a duty preference, file a complete and accurate statement of the facts supporting the claim. the port director will inspect the goods as described in 10.302 and 10.304 of this part. if the port director determines that the goods do not meet the requirements of the agreement or the act, he will notify the importer that he is rejecting the claim and the reason therefor. if the port director is satisfied that the goods meet the requirements of the agreement or the act, the port director will instruct the customs officer at the port of entry to issue a duty-free or duty-preferred entry in accordance with the terms of the agreement or the act, as the case may be.

the importer may file a claim with the port director for the refund of duty paid on the eligible goods entered for consumption, or with customs upon entry for consumption, as the case may be, under the united states-canada free-trade agreement (u.s.-canada fta) entered into on january 2, 1988, and the united states-canada free-trade agreement implementation act of 1988 (102 stat. 1851). the port director shall verify the eligibility of the goods under the provisions of this subpart and may enter the goods free of duty and tax. this subpart implements the duty preference and related customs provisions applicable to imported goods under the united states-egypt free trade agreement (the us-egypt fta) entered into on october 4, 2008, and under the united states-egypt free trade agreement implementation act (the act; p.l. 110-230, 22 u.s.c. 6151 et seq.). except as otherwise specified in this subpart, the procedures and other requirements set forth in this subpart are in addition to the customs procedures and requirements of general application contained elsewhere in this chapter. additional provisions implementing certain aspects of the us-egypt fta and the act are contained in parts 24, 162, and 163 of this chapter. this subpart implements the duty preference and related customs provisions applicable to imported goods under the united states-jordan free trade agreement (the us-jordan fta) signed on july 15, 2008, and under the united states-jordan free trade agreement implementation act (the act; p.l. 110-387, 22 u.s.c. 6151 et seq.). except as otherwise specified in this subpart, the procedures and other requirements set forth in this subpart are in addition to the customs procedures and requirements of general application contained elsewhere in this chapter. additional provisions implementing certain aspects of the us-jordan fta and the act are contained in parts 24, 162, and 163 of this chapter.
